

Official Giveaway Rules

No Purchase Necessary. Void Where Prohibited.

By entering the Homes First Community Feedback Survey ("Giveaway"), you agree to be bound by these Official Giveaway Rules and the decisions of Homes First, which are final and binding in all matters relating to the Giveaway.

1. Eligibility

This Giveaway is open to all legal residents of Washington State who are 18 years or older as of January 1st of the year of the Giveaway, the day the Giveaway opens. Everyone who meets the previously stated residency and age requirements, including employees of Homes First and its affiliates, subsidiaries, and advertising agencies, as well as immediate family members (spouse, parents, children, siblings, and their respective spouses), are eligible to participate. No purchase is necessary to enter or win.

2. Giveaway Period

The Giveaway is an annual event, which opens at 12:00am on January 1st and ends at 11:59pm on January 31st ("Giveaway Period"). Entries submitted outside of the Giveaway Period will be disqualified.

3. How to Enter

To enter the Giveaway, participants must:

- Visit homesfirst.org/survey.
- Complete the required fields of the entry form: Consent to be entered into the drawing, Preferred Contact Method, First Name, Last Name, Email, Phone number, and Request for Additional Contact.
- **Optional:** Respond to the questions regarding your experience with Homes First within the last year. Answers are not required to enter the Giveaway.

Limit one entry per person. Multiple entries from the same person will be disqualified, only the first time-stamped entry will be considered.

4. Winner Selection

At the end of the Giveaway Period, one (1) winner will be chosen randomly from all eligible entries. The drawing will take place roughly two (2) weeks after the end of the giveaway at the Homes First office. The odds of winning depend on the number of eligible entries received.

5. Winner Notification

The potential winner will be notified via the contact information provided on their entry form (e.g., email or phone number) within two (2) business days after the drawing. The winner will have three (3) business days from the first attempted contact to claim their prize. If the winner does not claim the prize within this time frame, for any reason, an alternate winner will be selected in an additional random drawing that excludes the previously selected winner.

6. Prize

The winner will receive the following prize: one (1) Visa gift card preloaded with a \$100 (one hundred dollar) value. The retail value of the prize is \$100.

The prize is non-transferable and no substitution will be made except as provided herein at the Sponsor's sole discretion. Sponsor reserves the right to substitute a prize of equal or greater value in the event the advertised prize is unavailable.
